Combined Giving Self-Service has been created to offer a paperless contribution method and provide users more freedom to initiate, revise, and/or cancel their contributions at any time.









Key Things to Know

- Selected contributions are on-going. Any contributions will be deducted from your paycheck every pay period.
- Due to the timing of the changes made, there could be a delay of up to one pay period before you see your elected changes. If you wish to make a One-Time contribution, it is up to you to go back in and remove the contribution once the One-Time contribution is taken from your paycheck.
- You are still able to contribute to the “Your Choice” option. This option allows you to contribute to a charity that is not currently part of the Combined Giving campaign. To do so, select the “Your Choice” Agency that corresponds with the given Federation and the desired contribution amount. A paper form will still need to be submitted to EBSD designating the chosen charity and their information.
- If you have an email saved in EMACS, any time you add, change, or delete your Combined Giving contributions, you will receive an email notification that a change has occurred.





7) Once you select an Agency, you will return to the “Add Deduction” screen to input the amount you would like to contribute to this Agency

9) Your selection will show on your Combined Giving screen along with the total contribution being made.




